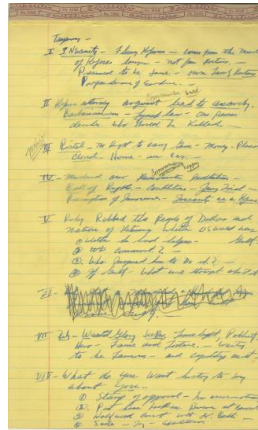

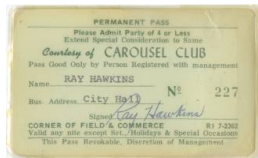
Title: Signed court document arranging EEG for Jack Ruby

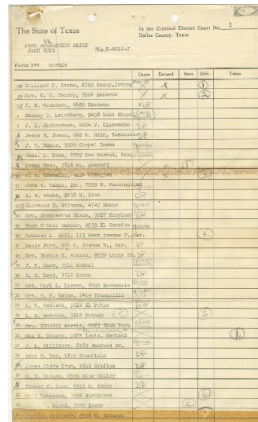
Title: Henry Wade's handwritten notes for closing arguments in Ruby trial

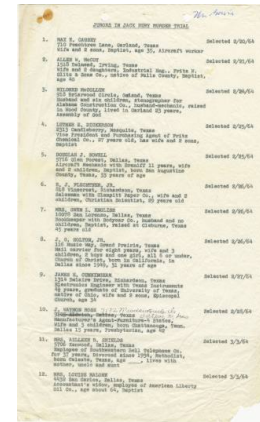
Title: Photo card advertising exotic dancer Jada at Jack Ruby's Carousel Club

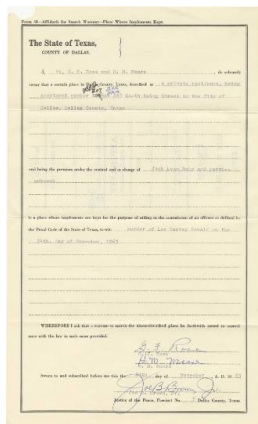
Title: Membership card to Jack Ruby's Carousel Club

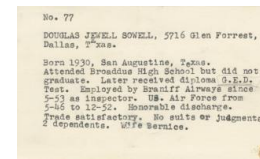
Title: List of selected jurors for the State of Texas vs. Jack Ruby trial

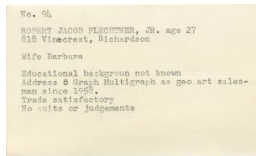
Title: Affidavit for search warrant of Jack Ruby's residence

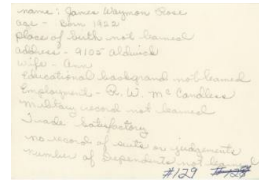
Title: Notecard about Ruby trial juror Robert Flechtner from the DA's Ruby file

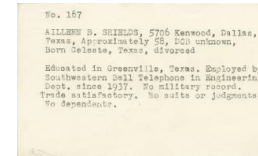
Title: Notecard about Ruby trial juror Waymon Rose from the DA's Ruby file

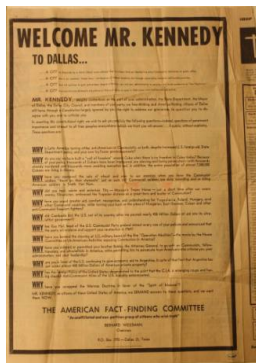


Title: Jack Ruby's address book with Dallas Police Department evidence tag

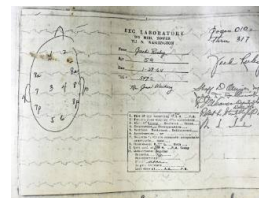


Title: Jack Ruby's copy of the "Welcome Mr. Kennedy" anti-Kennedy ad

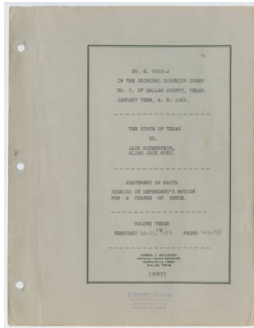
Title: Copy of pp. 12-13 for an electroencephalograph (EEG) test performed on Jack Ruby

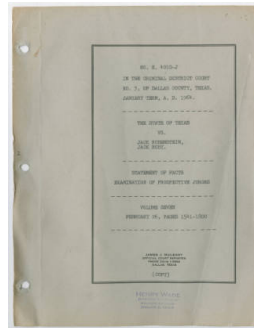


Title: T05 Transcript of State vs. Ruby: Motion for a Change of Venue, Volume 3

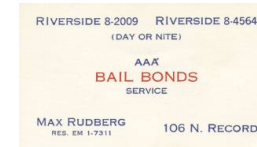


Title: T12 Transcript of The State vs Ruby, Examination of Prospective Jurors, Volume 7
