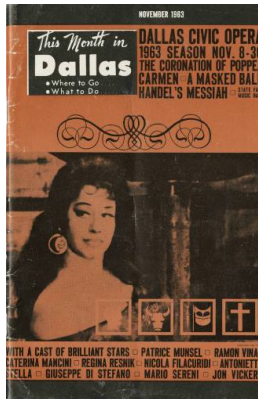

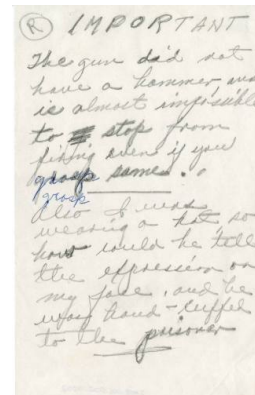
Title: Image of Judge Joe B. Brown surrounded by the press after the Ruby verdict

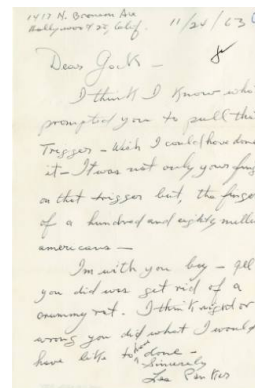

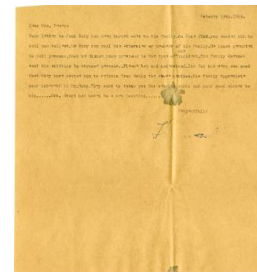

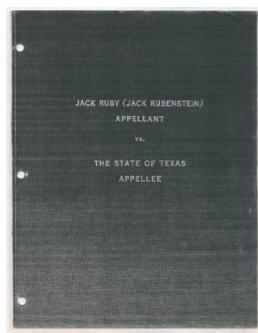

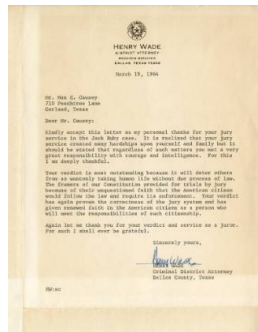

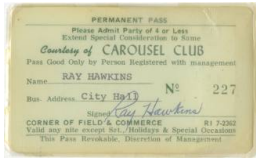

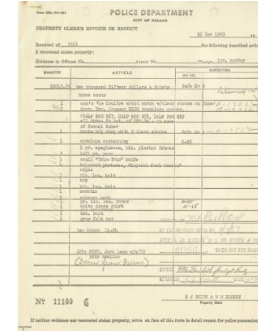

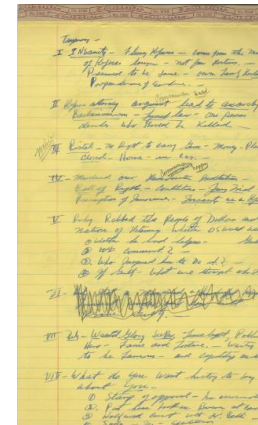
Title: Copy of a cover page for an electroencephalograph (EEG) test for Jack Ruby

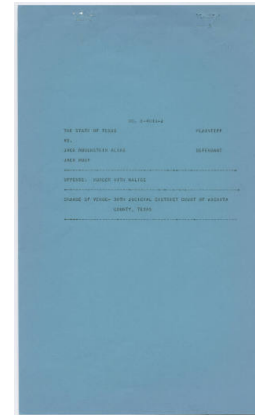


Title: T34 Supplemental Transcript to a Writ of Habeas Corpus for Jack Ruby, 1966

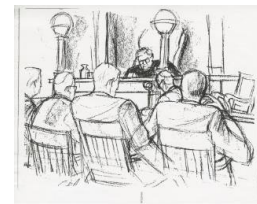
