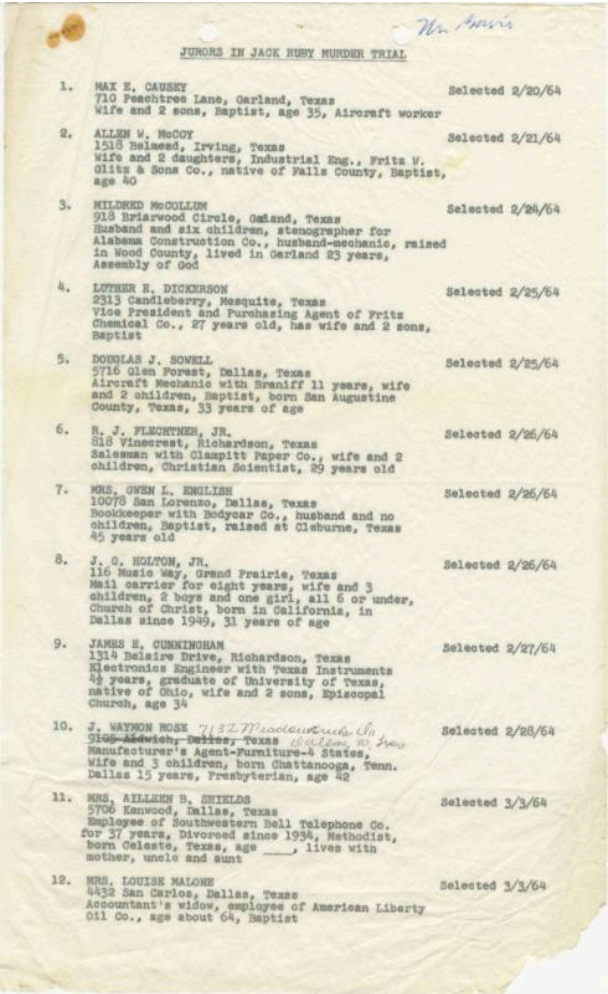

Flechtner, Jr., Selected 2/26/64 [address], Richardson, Texas Salesman with Clampitt Paper Co., wife and 2 children, Christian Scientist, 29 years old 7. Mrs. Gwen L. English, Selected 2/26/64 [address], Dallas, Texas Bookkeeper with Bodycar Co., husband and no children, Baptist, raised at Cleburne, Texas 45 years old 8. J. G. J. Waymon Rose, Selected 2/28/64 [address], Dallas, Texas Manufacturer's Agent-Furniture-4 States, Wife and 3 children, born Chattanooga, Tenn. Dallas 15 years, Presbyterian, age 42 11. Mrs. Aillean B. Shields, Selected 3/3/64 [address], Dallas, Texas Employee of Southwestern Bell Telephone Co. for 37 years, Divorced since 1934, Methodist, born Celeste, Texas, age ____ [sic], lives with mother, uncle and aunt 12. Mrs. Louise Malone, Selected 3/3/64 [address], Dallas, Texas Accountant's widow, employee of American Liberty Oil Co., age about 64, Baptist". This object was originally part of the evidence collected by the Dallas County District Attorney's Office and specifically prosecutors Henry Wade and Bill Alexander during the investigation leading up to the Jack Ruby trial for the murder of Lee Harvey Oswald.
